

ORDINANCE NO. 41

AN ORDINANCE ADOPTING THE POCAHONTAS COUNTY  
CODE OF ORDINANCES, 2020

BE IT ENACTED BY BOARD OF SUPERVISORS, POCAHONTAS, IOWA:

SECTION 1. PURPOSE: Code of Iowa, Section 331.302, subsection ten requires that once every five years a county shall compile its code of ordinances. This ordinance readopts ordinances already in effect.

SECTION 2. READOPTION OF CURRENT CODE: The following ordinances have been previously adopted and enacted into law and were duly published as the law provides. They are stated herein by subject matter. Therefore, by the authority of the Pocahontas County Board of Supervisors, the following shall compromise the Pocahontas County Code of Ordinances:
