The Pocahontas County Board of Supervisors met for the organizational meeting pursuant to Chapter 331.213 of the Code of Iowa.

Members present: Chairman, Brent Aden; Supervisors, Jeff Ives, Louis Stauter, Clarence Siepker, Kyle Smith; and Auditor, Kelly Jepsen. Others present: Reporter, Erin Sommers.

The first item of business was the election of Chairman and Vice-Chairman by secret ballot. The ballot count was as follows: Chairman: Kyle Smith-4, Clarence Siepker-1; Vice-Chairman: Jeff Ives-3, Clarence Siepker-2, The Board affirmed the vote and declared Kyle Smith as Chairman and Jeff Ives as Vice-Chairman for the 2024 calendar year.

Motion by Aden, seconded by Siepker, to approve the minutes, dated December 26, 2023, as presented. Ayes all, motion carried.

The tentative agenda was approved with striking possible closed session, on motion by Stauter, seconded by Ives. Ayes all, motion carried.

Motion by Stauter, seconded by Ives, to set Tuesdays as the 2024 regular meeting day for the Board of Supervisors commencing at 10:00 a.m. and with claims being approved, audited, and allowed on the second and fourth Tuesdays of each month. Ayes all, motion carried.

Motion by Ives, seconded by Aden, to utilize Roberts Rules of Order to conduct the meetings of the Board of Supervisors. Ayes all, motion carried.

The Pocahontas Record Democrat, The Laurens Sun, and the Buena Vista Journal, each having filed letters requesting to be the official newspapers for Pocahontas County, IA for the 2024 calendar year, with each stating they meet the requirements as stated in Iowa Code 618.3. Motion by Siepker, seconded by Stauter, to approve all applicants as the official newspapers of Pocahontas County. Ayes all, motion carried.

Motion by Siepker, seconded by Stauter, to declare the County holidays of non-union employees for the 2024 calendar year as follows: New Year's Day, Presidents Day, Good Friday, Memorial Day, Independence Day (July 4th), Labor Day, Veterans Day, Thanksgiving Day, the Day after Thanksgiving, and Christmas Day. The mileage reimbursement was reviewed. The Internal Revenue Service (IRS) has announced the standard mileage rate for the 2024 year for business use of an automobile is 67¢ per mile. Motion by Stauter, seconded by Siepker, to set the mileage reimbursement rate as 58.5¢ per mile, effective January 1, 2024. Ayes-Stauter, Smith, Siepker, Aden; Nays-Ives. Motion carried.

Construction Evaluation Resolution

WHEREAS, only counties that have adopted a construction evaluation resolution can submit to the Department of Natural Resources (DNR) an adopted recommendation to approve or disapprove a construction permit application regarding a proposed confinement feeding operation structure; and

WHEREAS, only counties that have adopted a construction evaluation resolution and submitted an adopted recommendation may contest the DNR's decision regarding a specific application; and

WHEREAS, by adopting a construction evaluation resolution, the board of supervisors agrees to evaluate every construction permit application for a proposed confinement feeding operation structure received by the board of supervisors between February 1, 2024 and January 31, 2024 and submit an adopted recommendation regarding that application to the DNR; and

WHEREAS, the board of supervisors must conduct an evaluation of every construction permit application using the master matrix created in Iowa Code section 459.305, but the board's recommendation to the DNR may be based on the final score on the master matrix or may be based on reasons other than the final score on the master matrix;

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Pocahontas County hereby adopts this construction evaluation resolution pursuant to Iowa Code section 459.304(3).

Jack Moellering, County Engineer, advised that shortly after the letting on the South 34 Lizard Bridge located between Pocahontas and Calhoun County, Pocahontas County was informed that someone had damaged the Closed Bridge sign. Since Calhoun County was responsible for the sign, they contacted Calhoun County and Calhoun County said to have the

contractor take care of the sign. When Pocahontas County requested the contractor remove the signs, the contractor understood that to mean to start working on the bridge, which was a mistake since there was not a signed contract in place. Pocahontas County and the contractor have signed the contract but the DOT acting on behalf of the Federal Government, who is providing the funding for the bridge, has not signed the contract yet. Now the DOT will not sign the contract until they receive a signed letter from the Board agreeing to their stipulations. Moellering advised that thus far there are several line items on the contract that will no longer be paid for with Federal funds, including the mobilization charge of \$89,000.00. The Board instructed Moellering to arrange the meeting as soon as possible, so this can be resolved and the contractor can continue working on the bridge.

Gary Atherton, Assistant to the Engineer/Drainage Clerk, advised that a local contractor is doing tiling in Section 36, Grant Township and Section 31 of Lizard Township and requested that the State DOT pay for the boaring under Highway 4 so he can outlet into DD 22. The DOT is willing to do the boaring but wanted approval from the County that they are allowed to outlet into DD 22. Since the land is already in DD 22 and no annexation is needed, a motion was made by Stauter, seconded by Aden, to approve the outletting into DD 22. Ayes all, motion carried.

Weekly meetings: Ives- North Central Region of Workforce Development; Stauter-Nothing; Smith-Hog confinement smell concerns; Siepker-Nothing; and Aden-Solid Waste business.

Ives advised that there was a meeting of the remanence of the North Central Region of Workforce Development. Iowa Workforce Development has determined that they cannot justify the billings they submitted for the Director. They are now being told that they have to repay with non-federal funds, which is \$1,800 per county or request an offset through the Adult Dislocated Worker funds. Several other regions are taking the offset and they have been advised to requesting the offset of future funds from the Adult Dislocated Worker funds. Even though the North Central Region of Workforce Development no longer exist, the region is still liable. Ives with keep the rest of the Board informed as more information becomes available.
