Supervisors Room, Courthouse Pocahontas, Iowa January 9, 2024

The Board of Supervisors of Pocahontas County, Iowa, met for a regular session pursuant to adjournment. Members present: Chairman, Kyle Smith; Supervisors, Jeff Ives, Louis Stauter, Clarence Siepker, Brent Aden; and Auditor, Kelly Jepsen. Others present telephonically: Reporter, Erin Sommers.

Motion by Siepker, seconded by Aden, to approve the minutes from January 2, 2024 as presented. Ayes all, motion carried.

Motion by Stauter, seconded by Ives, to approve the agenda with striking meeting with librarians and insurance agents. Ayes all, motion carried.

The Board reviewed the Recorder's, Auditor's, and Sheriff's Quarterly Reports and the Recorder's December Report of Fees Collected. Motion was made by Aden, seconded by Stauter, to approve said reports. Ayes all, motion carried.

Motion by Stauter, seconded by Siepker, to approve Terry Gunnarson's claim for repairs in Tri Jt. DD 73 for \$895.50. Ayes all, motion carried. Repairs took place in the SW Quarter of Section 33, Booth Township, Palo Alto County.

Motion by Siepker, seconded by Aden, to approve Hudson Law Firm's claim for professional services on Jt. DD 63 for \$75.00. Ayes all, motion carried.

Motion by Ives, seconded by Stauter, to approve Bolton & Menk's claim for professional services on Jt. DD 63 for \$3,885.00. Ayes all, motion carried.

The Pocahontas Chamber of Commerce requested use of the Courthouse lawn or the lot where the jail will be built for inflatables during Heritage Days. After discussion, a motion was made by Siepker, seconded by Stauter, to approve the Chamber's request, location is pending the progress of construction. Ayes all, motion carried.

Supervisor Smith advised that Four Way Contracting is requesting payment for roofing the walkway and garage at the Courthouse prior to giving the warranty. Smith has prior experience with the company and has no concern with not getting the warranty. Motion by Stauter, seconded by Aden, to authorize payment for said work. Ayes all, motion carried.

Motion by Siepker, seconded by Ives, to approve payment to Auditor, Kelly Jepsen, to prepare the FY 2024-2025 budget for \$5,000.00. After a long discussion on the responsibility of the budget, the Chairman called for a vote. Ayes-Ives, Siepker, Aden; Nays-Stauter, Smith. Motion carried.

Jack Moellering, County Engineer, presented two letters. One letter was from the Calhoun County Engineer agreeing to be the construction engineer responsible for administering the South 34 Lizard Bridge project. If Pocahontas County is agreeable, the Chairman would need to sign and a copy be sent to the DOT. The second letter is to the DOT, who had requested a letter from the County advising of the County's current and future federal aid administration plans. After discussion, a motion was made by Aden, seconded by Siepker, to authorize the Chairman to sign both letters. Ayes all, motion carried.

Moellering advised that the new Assistant County Engineer, Tate Schmeling's start date was changed from from February 1<sup>st</sup> to February 5<sup>th</sup>. Motion by Aden, seconded by Stauter, to acknowledge the change in Schmeling's start date. Ayes all, motion carried.

The Chairman signed the Easement Purchase Agreement with Cynthia A. Eichelberger for the South 34 Lizard Bridge project. It had been inadvertently not signed when previously approved.

Moellering and the Board discussed the recent snow storm and the hours the plows are in operation. Secondary Roads has a policy that the plows run between the hours of 6:00 a.m. and 6:00 p.m., as it is not advised to have the operators run for more than 12 hours at a time. Moellering advised that he could shift the times but he would prefer not to do because it would still be dark out, making it more difficult to operate the plows.
