Supervisors Room, Courthouse Pocahontas, Iowa March 12, 2024

The Board of Supervisors of Pocahontas County, Iowa, met for a regular session pursuant to adjournment. Members present: Chairman, Kyle Smith; Supervisors, Jeff Ives, Louis Stauter, Clarence Siepker; and Auditor, Kelly Jepsen. Supervisor, Brent Aden, was absent.

Motion by Siepker, seconded by Stauter, to approve the minutes from March 5, 2024 as presented. Ayes all, motion carried.

Motion by Stauter, seconded by Ives, to approve the agenda as posted. Ayes all, motion carried.

Landowner, Kirby Sampson, met with the Board to discuss the drain pipe under his private crossing. The County recently sent him a letter advising that his drain pipe was 4.5 feet too high, impeding the flow of water in DD 114. Sampson provided documentation on the build of the crossing and felt like it was a County issue with Bolton & Menk. The County will contact Bolton & Menk and do more research. Gary Atherton, Assistant to the Engineer/Drainage Clerk and Tate Schmeling, Asst. County Engineer were present for the discussion.

Sheriff Steve Nelson and Office Supervisor, Barb Hinners presented two quotes from Motorola Solutions. One quote was for five 4RE/V300 in-car video system and five V700 body worn cameras with a five-year subscription for \$44,653.00 plus \$200.00 for each V300 charging station. The other quote was for one of the exact same system from the first quote for a 1/5 of the cost plus \$975.00 for the annual license & support fee for the body camera, and \$975.00 for the annual license & support fee for the in-car video system. Motion by Stauter, seconded by Ives, to authorize the purchase of five 4RE/V300 in-car video system and five V700 body worn cameras with a five-year subscription for \$44,653.00 plus five V300 charging stations for \$1,000.00 from Motorola Solutions. Ayes all, motion carried.

Motion by Ives, seconded by Siepker, to approve a utility permit allowing Palmer Mutual Telephone Company to do underground construction across organized drainage district lands and approve the Iowa DOT agreement allowing Palmer Mutual Telephone Company use of highway Right-of-Way. Ayes all, motion carried. Work will be performed on 330<sup>th</sup> Ave. in Section 11 & 12, Lizard Township; 630<sup>th</sup> St. in Section 27, Bellville Township; 270<sup>th</sup> Ave. in Section 12, Lincoln Township; and 230<sup>th</sup> Ave., 610<sup>th</sup> St. and 220<sup>th</sup> Ave. in Section 18, Bellville Township.

Moellering handed out copies of the Secondary Roads' Seasonal Employee Employment Policy and their Drug and Alcohol Policy. The Board will review and place on next week's agenda.

Motion by Stauter, seconded by Ives, to acknowledge Jeffrey S. Kuchel's resignation from Civil Service Commission. Ayes all, motion carried. Kuchel was the County Attorney's appointee.

Motion by Ives, seconded by Siepker, to acknowledge the County Attorney's appointment of Noelle Murray to the Civil Service Commission for the remainder of the term ending December 31, 2024. Ayes all, motion carried.

Motion by Stauter, seconded by Siepker, to approve the Recorder's Report of Fees Collected for the month of February. Ayes all, motion carried.

Motion by Stauter, seconded by Ives, to approve the allowances, disallowances, and deletions for Family Farm and Ag Land tax credits for the 2023 valuation year, pursuant to Iowa Code 425A.4 and authorize the Chairman to sign letters to landowners who no longer qualify. Ayes all, motion carried.

Motion by Siepker, seconded by Ives, to approve Jt. DD 63 MOD claim for \$198.33 and Jt. DD 77 MOD claims for \$66.11 and \$264.44, all payable to Pocahontas County Secondary Roads for watchman services. Ayes all, motion carried.

Motion by Siepker, seconded by Stauter, to authorize a match for the ISAC Wellness incentive of \$100.00 for a physical exam and \$25.00 for completing the online assessment. Ayes all, motion carried. The public purpose is to encourage employees to participate in the Wellness program, which decreases the County's health insurance premium.

Auditor Jepsen and the Board discussed water damage found in the Conference Room on the third floor of the Courthouse and using prisoners to assist with different projects at the Courthouse. The Board would look at the Conference Room after the meeting. Jepsen will contact the prison about having some wooden chairs refinished at the prison. If they do a good job, then possibly have them come refinish the handrails at the Courthouse. Smith will contact Midstate Plumbing & Heating to see if using prisoners to help remove the current HVAC system would be cost effective.
