RESOLUTION AUTHORIZING THE ISSUANCE OF \$8,500,000 GENERAL OBLIGATION CAPITAL LOAN NOTES, SERIES 2024, AND LEVYING A TAX FOR THE PAYMENT THEREOF

WHEREAS, Pocahontas County, State of Iowa ("Issuer"), is a political subdivision, organized and existing under the Constitution and laws of the State of Iowa, and is not affected by any special legislation; and

WHEREAS, the Issuer is in need of funds to pay costs of designing, constructing, equipping and furnishing a new Pocahontas County Law Enforcement Center including all related site improvements (the "Project"), and it is deemed necessary and advisable that General Obligation Capital Loan Notes, Series 2024, in the amount of \$8,500,000 be issued; and

WHEREAS, the Board of Supervisors has taken such acts as are necessary to authorize issuance of the Notes.

NOW, THEREFORE, IT IS RESOLVED BY THE BOARD OF SUPERVISORS OF POCAHONTAS COUNTY, STATE OF IOWA:

Section 1. <u>Authorization of the Issuance</u>. General Obligation Capital Loan Notes, Series 2024, in the amount of \$8,500,000 shall be issued pursuant to the provisions of Iowa Code Sections 331.402 and 331.442 for the purposes covered by the election.

Section 2. <u>Levy of Annual Tax</u>. For the purpose of providing funds to pay the principal and interest as required under Chapter 76, there is levied for each future year the following direct annual tax upon all the taxable property in Pocahontas County, State of Iowa, to wit:

Principal and interest coming due at any time when the proceeds of the tax on hand are insufficient to pay the amount due shall be promptly paid when due from current funds available for that purpose and reimbursement must be made.

Section 3. <u>Amendment of Levy of Annual Tax</u>. Based upon the terms of the future sale of the Notes to be issued, this Board will file an amendment to this Resolution ("Amended Resolution") with the County Auditor.

Section 4. <u>Filing</u>. A certified copy of this Resolution shall be filed with the County Auditor of County of Pocahontas, State of Iowa, who shall, pursuant to Iowa Code Section 76.2, levy, assess and collect the tax in the same manner as other taxes and, when collected, these taxes shall be used only for the purpose of paying principal and interest on the Notes.
