The Board of Supervisors of Pocahontas County, Iowa, met for a regular session pursuant to adjournment. Members present: Chairman, Kyle Smith; Supervisors, Jeff Ives, Louis Stauter, Clarence Siepker, Brent Aden; and Auditor, Kelly Jepsen.

Motion by Stauter, seconded by Aden, to approve the minutes from April 30, 2024 as presented. Ayes all, motion carried.

Motion by Siepker, seconded by Ives, to approve the agenda with striking approving grant for ME-I training. Ayes all, motion carried.

The Board reviewed two quotes for a 36" wide Kripto Klaw Bucket: Road Machinery & Supplies Co. (RMS) from Sioux City, IA quoted \$31,750.00; and Mid Country Machinery, LLC. from Fort Dodge quoted \$27,131.11. Motion by Aden, seconded by Siepker, to authorize the purchase of the Kripto Klaw Bucket from Mid Country Machinery, LLC. for \$27,131.11. Ayes all, motion carried.

## Resolution 2024-05 #19 RESOLUTION FOR ROAD VACATION PUBLIC HEARING Pocahontas County

WHEREAS, The County Engineer has brought a request before the Pocahontas County Board of Supervisors asking that action be taken to vacate and close a section of Pocahontas County Secondary Road, described as follows:

That portion of 480<sup>th</sup> Street beginning 1400' east from 300<sup>th</sup> Avenue, east along the section line between sections 9 and 16 to 310<sup>th</sup> Avenue. This road being located in Garfield Township (T-92N, R-31W). and

NOW, THEREFORE BE IT RESOLVED that a public hearing on the proposed vacation will be held in the Board Room, Pocahontas County Courthouse, Pocahontas, Iowa, 50574, at 11:15 a.m. on Tuesday, 21<sup>th</sup> day of May, 2024 in accordance with Iowa Code Chapter 306.

WHEREAS, the remainder of this mile of road provides access to the parcels that would otherwise be landlocked, loss of access will not bar the vacation of this portion of County road.

BE IT FURTHER RESOLVED that it be considered at the public hearing: berm and ditch removal and what state the land should be left in following vacation.
