

**Supervisors Room, Courthouse
Pocahontas, Iowa
January 27, 2026**

The Board of Supervisors of Pocahontas County, Iowa, met for a regular session pursuant to adjournment. Members present: Chairman, Louis Stauter; Supervisors, Peter Seehusen, Clarence Siepker, Kyle Smith, Brent Aden; Laura Erickson, Deputy Auditor. Others present: Erin Sommers, Reporter, Katie Halligan, Pocahontas County Librarians: Lola DeWall, Laurie DeWall, Lorna Naeve, Glenda Mulder, Willa Casstevens, Mandy Pitstick and Stephanie Archer.

Motion by Smith, seconded by Seehusen to approve the minutes from January 20, 2026 as presented. Ayes all, motion carried.

Motion by Siepker, seconded by Aden to approve the agenda as posted. Ayes all, motion carried.

County Library Directors presented the county libraries report. 6 of the 9 county librarians were present. For FY27 budget, the libraries are asking for a 3.00 % increase. Chairman Stauter, thanked the librarians for all they do and that all budgets are tight. The Board may not be able to give an increase this year and may have to look at lowering donation.

Tate Schmeling, County Engineer presented a new hire letter to the board. Motion by Smith, seconded by Aden to approve the hire of Haley Toms as Drainage Engineer beginning the week of February 16, 2026 with a starting salary of \$95,000.00 once contract has been signed. Ayes all, motion carried.
