At 10:01 a.m., the Board had a conference call with Palo Alto County to discuss Jt. DD 63 Contractor's letter. The full minutes are available for review in the Auditor's office.

Jack Moellering, County Engineer, and the Board discussed the resumes received from Engineering students for a Summer Internship. Of the many resumes received, there were five that Moellering will reach out to for potential interviews.

Motion by Stauter, seconded by Smith, to approve the hire of Jayme C. Baker as a PT Jailer for the Sheriff's Department. Ayes all, motion carried. Baker's employment started October 2, 2023 making \$19.68/hr.

After discussing the need for a fertilizer spreader for the Courthouse, a motion was made by Smith, seconded by Stauter, to approve the purchase of a Tarter Fertilizer Spreader/Seeder from County Home Products for \$1,399.99. Ayes all, motion carried.

Motion by Ives, seconded by Smith, to approve DD 51's claim from Jacobson-Westergard for professional services in the amount of \$2,607.30. Ayes all, motion carried.

Motion by Siepker, seconded by Smith, to approve the Auditor's Quarterly Report and the Treasurer's Quarterly Investment Report for the period ending September 30, 2023. Ayes all, motion carried. The Quarterly Report notes that there was \$600.00 in cash in the Treasurer's Office, \$8,002,601.14 in CD's, \$3,214,270.08 in Stamped Drainage Warrants, \$1,262,085.71 in Drainage Improvement Certificates, and \$17,796,467.83 in banks, for a total of \$30,276,024.76. This quarter there was 1 CD renewed, interest earned totaled \$154,305.07, and 403 driver's licenses were issued generating \$2,821.00 in revenue.
