

**Supervisors Room, Courthouse
Pocahontas, Iowa
October 14, 2025**

At 9:45 the supervisors acting as trustees for Tri County Ditch 172-175-78 met telephonically with Webster County and Calhoun County to discuss Memorandum of Understanding regarding claims under \$5,000.00. Full minutes can be requested at the Auditor's office.

The Board of Supervisors of Pocahontas County, Iowa, met for a regular session pursuant to adjournment. Members present: Chairman, Clarence Siepker; Supervisors, Louis Stauter, Kyle Smith, Brent Aden; Nita Hinrickson, Auditor. Others present: Erin Sommers, Reporter; Tate Schmeling, Engineer; Amy Johnson, Treasurer; Erin Rydgren, Princess City Solar Rep. Absent: Peter Seehusen

Motion by Aden, seconded by Smith to approve the minutes from October 7, 2025 as presented. Ayes all, motion carried.

Motion by Smith, seconded by Stauter to approve the agenda as posted. Ayes all, motion carried.

Dereck Hebert, IT Director updated the board about the need to rebuild the county website to be ADA compliant with the most recent mandate. Hebert will be including in the FY27 budget.

Tate Schmeling, Engineer discussed posting for a part-time snow removal position. The board agreed with the posting. Schmeling also stated that there may be interest in the drainage engineer position but the individual doesn't live in the county and wanted to make sure the board was ok with that. The board was okay as long as the individual has the qualifications.

Schmeling provided a description for Lead Mechanic position with pay grade 17. After review, motion by Stauter, seconded by Aden to approve the promotion of Mike Shiflett to Lead Mechanic at \$32.44/hr. Ayes all, motion carried.

Schmeling advised that we should have final paperwork next week for the 3 road projects. He also received a rough quote from the railroad in the amount of \$250,000.00 to fix the road in between the tracks in Plover. The county is on the list for funding on this project, but there is no timeline to receiving the funding.

Amy Johnson, Treasurer requested the cancellation of 2 county held tax certificates and abatement of all taxes on 2 mobile homes. These mobile homes were torn down by park owners without going through the proper procedures. Motion by Stauter, seconded by Aden to approve the cancellation of the two held tax certifications and abate the taxes on these two mobile homes. Ayes all, motion carried.

Johnson also requested abating drainage assessment taxes of property owned by the federal government in the amount of \$174.37. The county receives federal money in lieu of taxes. Motion by Smith, seconded by Aden to approve the abatement of \$174.37 in drainage assessment. Ayes: Siepker, Smith Aden. Nays: Stauter. Motion carried.

Nita Hinrickson, Auditor presented three quotes from HR consulting firms. The supervisors will review the quotes further and will be added to next week's agenda for approving.

Hinrickson also advised that Alison Hauser has to have her information reported for the grant by Oct. 23 and then will report to the board on Oct. 28. Melissa Loehr, District 2 Leader for IPCA requested a meeting with the board. The board requested Nov. 18, after we hear from Hauser.

Hinrickson advised that the county received the renewal for Palmer Boosters liquor license. She requested IDR to send to the City of Palmer for approval.

Motion by Smith, seconded by Aden to approve the Resolution 2025-09-#39 adopting the MOU for no more than \$5,000 for Tri-County Drainage Ditch. Voice vote. Ayes: Stauter, Siepker, Smith, Aden. Nays – none. Absent: Peter Seehusen. Motion carried.

Motion by Stauter, seconded by Aden to approve the Treasurer's quarterly report. Ayes all, motion carried.

Motion by Smith, seconded by Aden to approve the Change Order for the LEC in the amount of \$6,173.80. Ayes all, motion carried.
