The Board of Supervisors of Pocahontas County, Iowa, met for a regular meeting. Members present: Chairman, Brent Aden; Supervisors, Louis Stauter, Clarence Siepker, Kyle Smith; and Auditor, Kelly Jepsen. Supervisor Jeff Ives was absent.

Motion by Smith, seconded by Siepker, to approve the minutes from November 14, 2023 as presented. Ayes all, motion carried.

The agenda was approved as posted on motion by Stauter, seconded by Smith. Ayes all, motion carried.

Family Crisis Center (FCC) representatives, Tara Raman, Director of Marketing & Development, and Yoseline Padilla, Advocate, met with the Board to give an update and thank them for their continued support. In the past year, FCC has served 14 Pocahontas County residents for domestic violence, 8 homicide & violent crimes, 8 through medical clinic outreach, and 17 crisis line calls. FCC requested a \$1,000 increase in funding for FY25. The Board thanked them for the services they offer to Pocahontas County residents.

Motion by Stauter, seconded by Siepker, to adopt the following resolution. The chairman called the question with the following recorded votes: Ayes: Aden, Stauter, Siepker, Smith. Nays: none. Whereby the Chairman declared the resolution duly adopted to-wit:

Revised Bridge Postings

WHEREAS, Pocahontas County receives significant federal funding for bridges and accordingly is required to conduct bridge inspections and where prescribed, to close or to place restrictions as to the weight of vehicles using such bridges, and

WHEREAS, the bridge inspection consultant for the County, a professional engineer, has previously determined bridge load postings according to vehicle type for several bridges in the County, and

WHEREAS, the County desires to maintain the safety of the public and continue receiving federal funding for bridge replacements, and

WHEREAS, four of the bridges that have been load posted for the above reasons are now being retrofitted with supplemental abutment supports, which will allow them to carry full legal loads.

NOW THEREFORE BE IT RESOLVED by the Pocahontas County Board of Supervisors that the postings on the bridges listed below be lifted and the roads be restored to full legal loads. These changes are to become effective once the roads are reopened after construction.
