Supervisors Room, Courthouse Pocahontas, Iowa November 28, 2023

The Board of Supervisors of Pocahontas County, Iowa, met for a regular session pursuant to adjournment. Members present: Chairman, Brent Aden; Supervisors, Jeff Ives, Louis Stauter, Clarence Siepker, Kyle Smith; and Auditor, Kelly Jepsen. Others present: Reporter, Erin Sommers.

Motion by Siepker, seconded by Smith, to approve the minutes from November 21, 2023 as presented. Ayes all, motion carried.

The agenda was approved as posted on motion by Ives, seconded by Stauter. Ayes all, motion carried.

Stacia Timmer, COO of Elderbridge Agency on Aging, met with the Board. Timmer thanked the Board for their financial support during the past fiscal year. In FY23 Pocahontas County contributed \$6,533 to Elderbridge and in return our residents received \$216,606 in services, a 3316% return on the County's investment. Timmer also requested a matching fund contribution of \$7,214 for FY25. The Board thanked Timmer and will consider her request during budget time.

John Hansen, Midwest Construction & Rick Weidner, AIA, met with the Board to discuss the new Law Enforcement Center. Hansen presented the preliminary time frame for the design, bidding & construction. Estimated construction would start no later than August 5, 2024 with the project completed by June 2025. While discussing the plans, the Board requested that the LEC include a "protected area" for the public to use during a severe storm since access to the Courthouse would no longer be available 24/7. Supervisor Smith advised that he, Supervisor Aden, and Treasurer, Amy Johnson met with the County's Bonding Agent, Travis Squires to discuss interim financing and the optimal time to bond. Squires advised that money could be used from the general fund to pay claims until the bonds are issued. Auditor Jepsen advised a budget amendment and a loan from Secondary Roads would be needed prior to paying any claims related to the LEC.

Hansen reviewed the request for proposal (RFP) for Civil Engineering Services from Jacobson-Westergard for \$21,500 and Beck Engineer, Inc. for \$26,400. Motion by Stauter, seconded by Ives, to award the bid to Jacobson-Westergard, not to exceed \$21,500.00 Ayes all, motion carried.

RFP for soil testing from Chosen Valley Testing, Inc for \$3,500 and Certified Testing Services, Inc. for \$3,550 were reviewed. Motion by Smith, seconded by Siepker, to hire Chosen Valley Testing, Inc to perform soil testing for \$3,500. Ayes all, motion carried.

Jack Moellering, County Engineer, advised that the Iowa DOT held bid lettings for the C-49 Overlay and the Lizard South 34 Bridge replacement. After review, a motion was made by Stauter, seconded by Smith to award the contract for the C-49 Overlay to Mathy Construction Company for \$2,655,314.53. Ayes all, motion carried. The work on C-49 will be between N-28 and Highway 4. Start date will be September 3, 2024.

Motion by Stauter, seconded by Siepker, to adopt by resolution authorization for Jack Moellering, County Engineer, to sign all documents on behalf of the Board of Supervisors for the C-49 Overlay project.
