

**Supervisors Room, Courthouse  
Pocahontas, Iowa  
December 2, 2025**

The Board of Supervisors of Pocahontas County, Iowa, met for a regular session pursuant to adjournment. Members present: Chairman, Clarence Siepker; Supervisors, Peter Seehusen, Louis Stauter, Kyle Smith, Brent Aden; Nita Hinrickson, Auditor. Others present: Erin Sommers, Reporter; Mike Shiflett, Lead Mechanic; Tate Schmeling, Engineer;

Motion by Aden, seconded by Seehusen to approve the minutes from November 25, 2025 as presented. Ayes all, motion carried.

Motion by Smith, seconded by Stauter to approve the agenda as posted. Ayes all, motion carried.

Tate Schmeling, Engineer & Mike Shiflett, Lead Mechanic reviewed the quote from Bendpak on a new hoist. After discussion, motion by Smith, seconded by Seehusen to approve new hoist quote in the amount of \$46,107.79. Ayes all, motion carried.

Schmeling then went over the Ditch Cleaning Policy. Schmeling advised that they have been doing what is in the policy, but they didn't have anything formal or the application. Motion by Stauter, seconded by Seehusen to approve ditch cleaning policy and application. Ayes all, motion carried.
