Supervisors Room, Courthouse Pocahontas, Iowa December 26, 2023

The Board of Supervisors of Pocahontas County, Iowa, met for a regular session pursuant to adjournment. Members present: Chairman, Brent Aden; Supervisors, Jeff Ives, Louis Stauter, Clarence Siepker, Kyle Smith; and Auditor, Kelly Jepsen.

Motion by Siepker, seconded by Smith, to approve the minutes from December 19, 2023 as presented. Ayes all, motion carried.

Motion by Ives, seconded by Stauter, to approve the agenda as presented. Ayes all, motion carried.

Rick Winegarden, County Compensation Board representative, presented the Compensation Board's recommendations for elected official salaries for FY25. With the Cost of Living increasing 4.32%, the Compensation Board recommended a 6.32% increase for all elected officials plus a \$1,000 stipend for the Board of Supervisors Chairman. The Board thanked Winegarden for his time. Motion by Ives, seconded by Stauter, to acknowledge receipt of the Compensation Board's recommendation. Ayes all, motion carried.

Motion by Stauter, seconded by Siepker, to approve Joe Zeman as a part time temporary seasonal employee for the 2023/2024 winter season at \$23.05 per hour. Ayes all, motion carried.

Jack Moellering and the Board discussed the Summer Internship, road work going on outside of Varina and the speed limit through Ware. Moellering had asked for the DOT to do a speed study for the area by Ware but had not heard back. He will follow up with the DOT and also inquire about speed studies for other areas in the County where land has been developed.

Auditor Jepsen and the Board discussed the County's budget responsibilities. Iowa Code 331.443 states that the duties of the County budget are that of the Board of Supervisors but the County Auditor has been performing those duties on behalf of the Board of Supervisors in Pocahontas County. Since the Iowa Code allows the Board the ability to contract for those services, Jepsen requested compensation for her time outside of normal work hours. Jepsen advised that she estimates that she spends over 80 hours outside of normal work hours on the County's budget. Jepsen also shared that retired Clay County's Auditor, Marge Pitts, advised Jepsen that her estimate was low, as she had tracked her time for the Clay County's Board of Supervisors and it was over 200 hours. After discussion, a motion was made by Siepker, seconded by Ives, to appoint the County Auditor, Kelly Jepsen, to be Budget Director for \$5,000.00 for FY25 budget. The chairman called the question with the following recorded votes: Ayes: Ives, Siepker; Nays: Stauter, Aden, Smith. Whereby the Chairman declared the resolution not adopted.
