The Board of Supervisors of Pocahontas County, Iowa, met for a regular session pursuant to adjournment. Members present: Chairman, Kyle Smith; Supervisors, Jeff Ives, Louis Stauter, Clarence Siepker, Brent Aden; Nita Hinrickson, Auditor. Others present: Reporter, Erin Sommers; Peter Seehusen; Dereck Hebert, IT; Gary Atherton, Assist. Engineer.

Motion by Clarence Siepker, seconded by Brent Aden, to approve the minutes from November 26, 2024 as presented. Ayes all, motion carried.

Old Business – ARPA funds. Dereck Hebert received the third quote from Midwest Alarm. Dereck reviewed the quotes and felt there were only two choices. Iowa Fire but that would only cover the Courthouse. Lynx Systems, which is cloud based, could utilize all county buildings. With Lynx Systems, we could eliminate panic buttons and utilize keys on a keyboard for \$5,450.00/year. Dereck will check on cost for hardware for the fire system. Lynx Systems can also provide mass notifications.

Nita Hinrickson, Auditor, advised the Board that she reached out to two other companies on painting the rotunda and will hopefully hear back this week. Tate Schmeling reviewed the invoice for their expenses for the Law Enforcement Center and was able to lower the cost. Nita will send the invoice to John Hansen to have it come out of the bond.

Nita also advised that Brian Reis had presented some options for the use of ARPA funds. Once painting quotes are received, the Board will look at other options for the rest of the funds. Nita will reach out to contractors and get a quote on siding, one garage door and windows for the building located east of the new LEC.

Louis Stauter asked about public storm shelter once the Sheriff's office moves to the new building. Nita will check with Steve Nelson to see if there will be space to utilize at the Law Enforcement Center.

Motion by Brent Aden, seconded by Clarence Siepker, to acknowledge Christina Poncin's 12 month's as full-time jailer/dispatcher with the Sheriff's Office. Her new rate of pay effective December 11, 2024 will be \$21.05/hr. Ayes all, motion carried.
