

**Supervisors Room, Courthouse
Pocahontas, Iowa
March 25, 2025**

The Board of Supervisors of Pocahontas County, Iowa, met for a regular session pursuant to adjournment. Members present: Chairman, Clarence Siepker; Supervisors, Peter Seehusen, Louis Stauffer, Kyle Smith, Brent Aden; Nita Hinrickson, Auditor. Others present: Erin Sommers, Reporter; Steve Nelson, Sheriff; Kalista Wagner, Assessor; Gary Atherton, Assistant to Engineer; Tate Schmeling, Engineer; Katie Halligan, Don Trexel, Daryl Anderson, Wessels Oil; Jim Kakacek, Pro Coop; Ryan Klaassen.

Motion by Aden, seconded by Seehusen to approve the minutes from March 18, 2025 as presented. Ayes all, motion carried.

Motion by Smith, seconded by Stauffer to approve the agenda as posted. Ayes all, motion carried.

Smith advised that he took pictures of Palo Alto courthouse and they only had 46 windows. The windows appeared to be residential style and were only 4x6 or 4x5. Supervisors will remove the windows from old business and will table looking at alternative options.

JT DD 9-13 conference call with Calhoun County to change appointment of drainage commissioners to Jerry Hammen and Jeff Ives. Calhoun County was lead and minutes are held in the Auditor's office.

Tate Schmeling, Engineer asked if the board was interested in subsidizing landowners for dust control again this year. Motion by Stauffer, seconded by Aden to authorize an \$80.00 subsidy for dust control to landowners, \$40.00 per application, up to two applications. Customer can choose Wessels Oil or Pro Coop. Seehusen asked what the benefit was, Schmeling advised the biggest benefit is environmental. Ayes: Stauffer, Siepker, Smith, Aden. Nay: Seehusen motion carried.

Schmeling discussed road vacancy request by landowner on 200-300 feet of road on 285th Ave in Section 31 in Lake Township by acreage. Discussion on if more than the 300' should be vacated. The amount of vacating can be discussed at the public hearing. Schmeling will present a Resolution at next weeks supervisor meeting to set a public hearing date.

Schmeling also discussed vacating the rest of 465th St. due to the bridge removal. Trexel asked if Conservation may be able to use and make a parking area for fishermen. Schmeling will present a Resolution at next weeks supervisor meeting to set a public hearing date.

Pursuant to Iowa Code section 427.1(22), a motion was made by Seehusen, seconded by Smith to approve the 2024 wetland applications (Natural Conservation and Wildlife Acres property tax exemption). Wagner advised these were reviewed in 2024. Ayes all, motion carried.

Motion by Seehusen, seconded by Aden to approve the allowances, disallowances, and deletions for Family Farm and Ag Land tax credits for the 2024 valuation year, pursuant to Iowa Code 425A.4 and authorize the Chairman to sign letter to landowners who no longer qualify. Ayes all, motion carried.

Motion by Stauffer, seconded by Aden to approve JT DD 1-54 Secondary Roads invoice for \$1,558.64 tile blowout. Atherton stated that the work order was done previously by Jack Moellering and that it took two days to finish it due to Secondary Roads needing to put in a "T" they didn't have one on hand and had to purchase one. Ayes all, motion carried.

Atherton was asked about the tile that was broken when pattern tiling was done by Luft. Luft has not fixed yet due to weather.

Motion by Aden, seconded by Seehusen to approve Manure Management Plans: (1) Rittgers Home Place – ID# 58467 NW NW, Section 7, Des Moines Township David Rittgers as owner & contact person. Ayes all, motion carried.

Motion by Aden, seconded by Smith to pay claims as presented. Ayes all, motion carried.
