## Approval of FY 23/24 Maximum Property Tax Dollars

WHEREAS, the Pocahontas County Board of Supervisors have considered the proposed FY 23/24 county maximum property tax dollars for both General County Services and Rural County Services, and

WHEREAS, a notice concerning the proposed county maximum property tax dollars was published as required and posted on the county website and social media accounts, and

WHEREAS, a public hearing concerning the proposed county maximum property tax dollars was held on March 28, 2023.

NOW THEREFORE BE IT RESOLVED by the Board of Supervisors of Pocahontas County that the maximum property tax dollars for General County Services and Rural County Services for FY 23/24 shall not exceed the following:

General County Services: \$5,224,975; an increase of 11.71% from the prior year

Rural County Services: \$2,538,256; an increase of 6.03% from the prior year

The Maximum Property Tax dollars requested in either General County Services or Rural County Services for FY 23/24 represents an increase greater than 102% of the Maximum Property Tax dollars requested for FY 22/23.
