

**Supervisors Room, Courthouse  
Pocahontas, Iowa  
April 22, 2025**

The Board of Supervisors of Pocahontas County, Iowa, met for a regular session pursuant to adjournment. Members present: Chairman, Clarence Siepker; Supervisors, Peter Seehusen, Louis Stauter, Kyle Smith, Brent Aden; Nita Hinrickson, Auditor. Others present: Erin Sommers, Reporter; Bryan Rahn, Drainage Clerk; Steve Nelson, Sheriff; Nate Reffer; B & W Control Specialist.

JT DD 63 Public Hearing conference call with Palo Alto County regarding voluntary annexation into DD63. Minutes can be requested at the auditor's office.

Following the hearing, motion by Smith, seconded by Seehusen to approve the minutes from April 15, 2025 as presented. Ayes all, motion carried.

Motion by Stauter, seconded by Seehusen to approve the agenda as posted. Ayes all, motion carried.

Nate Reffer, B & W Control Specialists, provided a quote for each drainage ditch in the rotation for 2025. They work on time & material and will not go over the amount quoted. The board advised they would review quotes and decide at the April 29, 2025 meeting.

Nita Hinrickson, Auditor informed the board there are 26 drainage ditches that look like assessments will need to be levied this year. Hinrickson will provide the board a list of the potential ditches at next week's meeting to review.

Hinrickson has a meeting with Alison Hauser on Thursday to go over her proposed budget for the grant. Hinrickson advised the board that after initial discussion with Hauser it looks like the county may have to provide funds that are not covered by the grant or Humboldt County. More information will be provided to the board next week.

Rotunda painters have started. Reminder that Feenstra visit in Fonda is this afternoon.

There was also a meeting this morning with a rep from IMWCA.
