Supervisors Room, Courthouse Pocahontas, Iowa May 25, 2021

The Board of Supervisors of Pocahontas County, Iowa, met in regular session pursuant to adjournment. Members present: Chairman, Clarence Siepker; Supervisors, Jeffrey Ives, Brent Aden, Louis Stauter, Kyle Smith; and Auditor, Kelly Jepsen. Others Present: Reporter, Erin Sommers.

Motion by Stauter, seconded by Aden, to approve the minutes, dated May 18, 2021, with changes. Ayes all, motion carried.

Motion by Ives, seconded by Smith, to approve the tentative agenda as posted. Ayes all, motion carried.

Supervisor Ives advised that a group representing both EMA and Public Health met to discuss the new building approved at the May 4, 2021 Board Meeting. After reviewing EMA and Public Health's needs and reviewing amended quotes from the original bidders: Todd Morton, from Gillet Grove on a Reaves Building Systems and Tom Witt Contractor, Inc. from Newell, IA on a Lester Building, they recommend the Reaves' stick frame building. The Building would be a 60'x120'x16' stick frame building with rafters on 8' center for a total cost of \$142,633.44. They also recommend the Gonnerman/Rubel Construction estimate for a 60' x 120' concrete floor, for \$69,180.00. Motion by Ives, seconded by Smith, to accept the changes to the design of the building and accept the bid from Gonnerman/Rubel Construction for the concrete work for this building. Ayes all, motion carried. The design will be changed from a Reaves pole building with rafters on 4' center, for \$145,621.00 to a Reaves stick building with rafters on 8' center, for \$142,633.44.

Cathy Frerk, County Recorder, requested to make Beverly Tiedeman a Deputy Recorder as of June 1, 2021 and adjust her wages to 66% of the Recorder's salary. After discussion a motion was made by Aden, seconded by Stauter, to approve the appointment of the Deputy Recorder, effective July 1, 2021, by resolution. The chairman called the question with the following recorded vote: Ayes –Ives, Aden, Siepker, Stauter, Smith; Nays-none. Whereby the Chairman declared the resolution duly adopted to-wit:

A letter was received from Collin Klingbeil, Project Engineer from Bolton & Menk, certifying that Reutzel Excavating, Inc. had completed the improvement on Jt. DD 63 Br. Main Tile. In accordance with Iowa Code 468.101, motion was made by Ives, seconded by Smith, to acknowledge the completion and set the completion hearing for Tuesday, June 15, 2021 at 1:30 pm at the Election's Center in Emmetsburg, Iowa. Ayes all, motion carried.

Motion by Stauter, seconded by Aden, to approve Jt. DD 63 Main Open Ditch claim from Bolton & Menk, Inc., for engineering service on FEMA work for \$478.50. Ayes all, motion carried.

Motion by Ives, seconded by Stauter, to approve Jt. DD 63 Br. Main Tile claim from Bolton & Menk, Inc., for engineering service for \$4,420.00. Ayes all, motion carried.

Motion by Aden, seconded by Smith, to acknowledge receipt of Manure Management Plan: (1) Seehusen Finisher –ID# 61832, located in the SE SW, Section 30, Sherman Township, with Middle Creek Swine, LLC as owner & Maschhoff Environmental Inc. as contact person. Ayes all, motion carried.

Ann Beneke, on behalf of the City of Laurens, requested the assignment of the County held certificate on parcel #01-22-357-006, located at 534 W. Section Line Rd. in Laurens, and a waiver on the redemption. Motion by Stauter, seconded by Aden, to assign the tax certificate #2015-199, to the City of Laurens and abate the taxes as soon as the city takes possession except for the drainage assessment of \$27.70 and the assignment fee of \$10.00. Ayes all, motion carried. Taxes that will be abated, \$9,157.28.

Amy Johnson, County Treasurer, requested to make Michelle Ferguson a Driver's license Deputy. Motion by Ives, seconded by Stauter, to approve the appointment of the Driver's license Deputy, effective July 1, 2021, by resolution. The chairman called the question with the following recorded vote: Ayes –Ives, Aden, Siepker, Stauter, Smith; Naysnone. Whereby the Chairman declared the resolution duly adopted to-wit:

WHEREAS, approval of each appointment shall be adopted by resolution recorded in the minutes of the Board of Supervisors;

NOW THEREFORE BE IT RESOLVED by the Pocahontas County Board of Supervisors that the following appointment by the Treasurer is approved: Michelle Ferguson, Driver's License Deputy.

Next Johnson requested a wage increase for Denise Krischel, Tax Deputy, and Michelle Ferguson, Driver's license Deputy. Johnson would like to increase Krischel from 79% to 81% of the Treasurer's salary and Ferguson from \$18.00 per hour to 58% of the Treasurer's salary, both effective June 1, 2021. Motion by Smith, seconded by Aden to approve said wage increases with the effective date of July 1, 2021. Ayes all, motion carried.

Half of the American's Rescue Plan fund, \$642,831.50 was deposited to the County's main account on Friday, May 21, 2021. Treasurer, Amy Johnson, questioned the need to have a separate account for the funds. After discussion, a motion was made by Aden, seconded by Smith, to authorize the County Treasurer to open a new account at Pocahontas State Bank to be used solely for the funds received from the American's Rescue Plan. Ayes all, motion carried.

Motion by Stauter, seconded by Smith to award the bid to Iowa Plains Signing, from Slater, IA, for \$116,533.00. Ayes all, motion carried.

Moellering gave an update on Secondary Roads current projects: Moellering advised that the bridge located on the west side of Section 18, Dover Township, is currently being replaced.

Weekly meetings: Ives-Workforce Development and drainage concerns; Aden-Windmill concerns; Siepker-Upper Des Moines Finance meeting and Linking Families Executive Board meeting; Stauter-YES Center; and Smith-Public Health and Home Care Aide Agency joint meeting. All Supervisors participated in the DD 59 Annexation and Reclassification Hearings.
