

## **NOTICE OF ELECTION CITY OF ROLFE SPECIAL ELECTION TO FILL VACANCIES**

Public notice is hereby given to the qualified electors of the City of Rolfe, in the county of Pocahontas, State of Iowa, that a Special Election to fill vacancies on the Rolfe City Council will be held on Tuesday, September 28, 2021. Voters will elect three (3) City Council Members to fill vacancy, term ending December 31, 2021 and two (2) City Council Members to fill vacancy, term ending December 31, 2023.

For the special election, held on September 28, 2021, voting will be located in the Rolfe Community Center, 319 Garfield St. Rolfe, IA from 7:00 a.m. to 8:00 p.m.

Pre-registered voters are required to provide an approved form of identification at the polling place before receiving and casting a regular ballot. Voters who are not pre-registered, such as voters registering to vote on Election Day and voters changing precincts, must also provide proof of residence. A voter who is unable to provide an approved form of identification (or prove residence if required) 1.) may have voter's identity/residence attested to by another registered voter in the precinct. Attesters for voters unable to provide proper identification at the polls must themselves provide proper identification before signing the attester's oath. 2.) prove identity and residence using Election Day Registration documents, or 3.) cast a provisional ballot and provide proof of identity/residence at the County Auditor's office by NOON on Monday, October 4, 2021. Any voter who requires assistance to vote by reason of blindness, disability or inability to read or write may be given assistance by a person of the voter's choice, other than the voter's employer or agent of that employer or officer or agent of the voter's union.

NOTICE ALSO GIVEN to the qualified electors in the county of Pocahontas, State of Iowa, in accordance with Chapter 52.35 of the Iowa Code that the Commissioner's duly authorized agents shall examine and test the vote tallying equipment for the September 28, 2021, City of Rolfe Special Election beginning Thursday, September 23, 2021 at 9:00 a.m. and will continue until completed. The certification testing for said election is open to the public in the Supervisors Room of the Pocahontas County Courthouse, 99 Court Square, Pocahontas, Iowa.
