

## **Meredith Park Facilities**

Meredith Park, also known as Plover Pit, features an excellent 5 1/2 acre natural swimming and fishing lake.

Camping facilities consist of 17 sites with water and 50 amp electrical service, graveled pads, picnic tables and grills. A modern shower/restroom building is located in the camping area. Firewood and a septic dump station is also available. An open shelter house is available for use by campers unless reserved.

Camping rates for the 2018 season are \$20/night for a pad with electricity/water. The shelter may be reserved for \$20/day. Firewood is \$3/armload. The park is closed from 10:30 p.m. to 6:30 a.m. except for campers.

Meredith Park also features a new playground. Created from 15,000 recycled milk jugs, the slides, climbing wall, fort area and swings offer a safe, fun place for kids to play.

## **Cabin Rules**

- Check-in time is 3:00 p.m. Check-out time is 1:00 p.m.
- Guests must be at least 21 years old to reserve or occupy a cabin unless accompanied by an adult.
- Maximum occupancy is 8 people.
- Tents and RVs are not permitted at the cabin site.
- Cooking, other than with microwave, crock pot, coffee maker or a toaster is prohibited inside the cabin. A grill is provided outside.
- No smoking is allowed in the cabin.
- Pets are not allowed in the cabin or on the cabin site.
- No keg beer is allowed in the cabin or on the cabin site.
- The park closes at 10:30 p.m. All unregistered guests must leave the park by this time.
- All other park rules are in effect.
- The Pocahontas County Conservation Board staff reserves the right to enter the cabin in emergencies or for security problems.
- The Pocahontas County Conservation Board staff has authority to refuse rental privileges and rescind any and all rental permits for cause.





## **Meredith Park Camper Cabin**



Meredith Park, located 1 1/2 miles north of Plover on N57 in north central Pocahontas County, is a popular place for fishing, swimming, picnicking, and camping.

During the summer of 2007, PCCB joined with Prairie Partners RC & D to construct a sleeping cabin out of Iowa native white oak logs. Quietly tucked among willows and cottonwoods along the south lakeshore, the cabin offers a secluded spot to relax and enjoy the outdoors with family and friends. With the addition of the new cabin, PCCB predicts the former gravel pit will be even more popular.





## Cabin Furnishings

The cabin at Meredith Park is heated and air-conditioned and has electricity. The kitchen area is furnished with a microwave and small refrigerator. Oak cabinets provide storage and work space. A table and benches may be used for eating meals or playing board games. A full-sized bunk bed and futon offer comfortable sleeping for six people.

A park bench provides porch seating along with a wonderful view of the lake.

A fire ring, upright grill, picnic table, and water hydrant are located just outside the cabin. Firewood is available in the campground. Parking, a shower house, and modern restrooms are just a short walk to the east.
